

OFFER FOR THE FINLAND JOINT STAND DMEA 8. – 10.4.2025

At the DMEA health IT exhibition held in Berlin, administrative managers, doctors, and equivalent healthcare professionals from German, Austrian, and Swiss hospitals, clinics, and care facilities visit the event. The DMEA exhibition provides a comprehensive overview of the industry's technologies. Exhibitors showcase digital solutions for the health and healthcare sectors. In 2024, the exhibition was attended by over 18,000 industry professionals, with a 10% increase in professional visitors. The 2024 event featured 800 exhibitors, including 16 from Finland. And the next event will take place from 8 to 10 April 2025.

We invite you to the DMEA exhibition at the joint Finnish stand. The Finnish joint stand offers an excellent opportunity to explore the market and acquire leads. By submitting your registration, you confirm your participation at the Finland stand. Please note that we aim to integrate the Finnish joint stand into the Nordic pavilion, through which we seek greater visibility for our participation. Other Nordic countries will decide on their participation in October, at which point the Nordic pavilion will be confirmed. If other Nordic countries do not participate or if the event organizer does not allocate suitable space, Messuille Oy will implement the Finnish stand as per the visual plans for the Finnish section.

Early Bird Finland Stand Package: €6,000 + VAT per company Registration by 4 October 2024.


Regular Finland Stand Package: €6,500 + VAT per company For registrations after 5 October 2024, as long as space is available.


Companies can apply for Business Finland's exhibition support for participation. If granted, the support covers 50% of the participation fee. Messuille Oy will provide additional information on how to apply for the support.

The Finland Stand Package includes:
